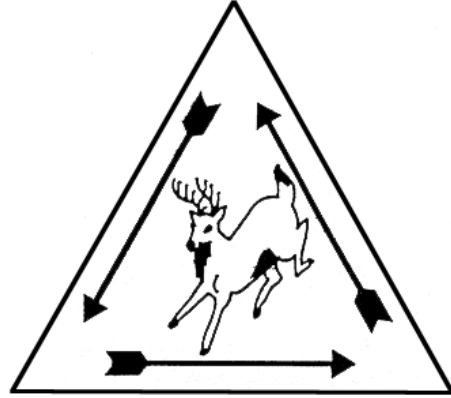


Unali'yi Lodge 236

Vigil Honor Nomination Form



The Vigil Honor is the highest honor the Order of the Arrow (OA) can bestow upon its members. It is a mark of high distinction and recognition reserved for those Arrowmen who, by reason of exceptional service, personal effort, and unselfish interest have made distinguished contributions beyond the immediate responsibilities of their position of office to one or more of the following: their unit, their lodge, the OA, Scouting, or their Scout Camp. Under no circumstances should tenure in Scouting or the Order of the Arrow be considered as reason enough for a Vigil Honor recommendation. Membership cannot be won by a person's conscious endeavor; it comes as recognition of their altruistic leadership in service. This fact should be given careful consideration in the nomination of any candidate.

2. Must be a member in good standing with Unali'yi Lodge 236.
3. At time of nomination, must have been a Brotherhood member for a minimum of two (2) years.
